The Council continue to crack down on enviro-crimes and anti-social behaviour in County Durham. During May 77 fixed penalty notices were issued – 24 of which were for dog fouling, 39 for littering and 14 for failure to comply with a litter clearing notice for an untidy yard or garden. A successful prosecution was also brought against a man found guilty of fly-tipping in the East Durham area. 72 reports of anti-social behaviour were covered, and there were 78 seizures of alcohol from underage drinkers.

Police, Community Support Officers and neighbourhood wardens, can issue fixed penalty notices for enviro-crimes and anti-social behaviour.

3. Flooding in Bowburn: Simon Longstaff, Drainage and Coastal Protection Manager, DCC reported that: An initial survey identified ditching works that are needed and found the bed on the culvert running past the Community Centre to be covered with gravel. Although this is not a major issue for the movement of water, the bed of the culvert needs to be as clean as possible so that a camera tractor can carry out a survey. Some of the ditching works near the allotments have already been carried out; the remaining section of ditching from the footbridge at Charlesworth Close to the culvert inlet will be done at the time of the survey works. NWL surface water sewers discharge into the culvert and DCC are interested in checking these; there are also some cleansing works to be carried out downstream of the culvert outlet.

Members made the following points:

- >Either make the culvert bigger or reduce the amount of water coming into the culvert as there is too much combined water (surface and sewage) having to flow into the beck through drains with limited capacity. This might be achieved by taking more surface water directly to the beck west of Durham Road, by increasing attenuation measures higher up the system (for instance in new housing estates) or by a complete overhaul of the system.
- >More thought needs to be given to the regular clearing of the culvert, to speed up the escape of surface water, even if the culvert cannot be increased in size.
- >The flood problem at the Old Quarrington Road junction proved that the situation would have been worse near the Community Centre if water had not been held back at that junction.
- >More consideration needs to be given to flooding issues in planning applications eg 'The Daisy Field' which was agreed by NWL; at least one local house insurance company now mentioned that housing, even several feet about actual flood levels, was in a "flood area". It was believed, however, this had not yet affected insurance premiums.

The chair had earlier put the following query "Where does the County believe legal responsibility lies with flooding issues? Now that they are the Lead Flood Authority - if there is a flooding problem resulting from, say, a planning decision and negligence can be established - would it be appropriate to sue the Council even if they relied on advice from say, NWL?"

Simon has left the question with the legal team and will get back to the Partnership when he has a response. **(Janet)** Simon thanked members for their suggestions and would keep them updated. He added that DCC have high standards of checking for flood areas on plans.

Simon was thanked for his attendance at the meeting and left at 7.00pm

7A. Regeneration Fund: Project updates:

001 Parkhill play equipment: A Richardson advised that the third and final quotation for play equipment is needed before the application can be made.

002 Youth Club: *Some of the works are complete and ready to be put into use.*

004 Community Chest: The project is on hold depending on the funds remaining.

● R Swales (lavin) Head of Business Strategy & Inclusion talked on the Welfare Reform Escalation Plan.
