<u>2iii. Neighbourhood Wardens</u>: Monthly report for the Durham City Area.

Dog fouling: Investigated 30 reports; Removed 14 stray dogs.

Littering: Investigated 3 reports: Issued 27 fixed penalty notices.

Fly-tipping: 121incidents reported; 59 investigations to link the fly-tipping to those who dumped it;

Issued 2 household duty-of-care letters and 2 business duty-of-care letters.

<u>Untidy yards and gardens</u>: Issued 8 advisory letters and 4 litter clearing notices.

<u>Antisocial behaviour</u>: 14 incidents of ASB reported directly by members of the public, and 42 incidents were passed via the Police Airwaves system.

The Civic Pride Team: Launched the Beautiful Durham competition which is open to residents, parish councils, environmental groups and businesses within the Durham City area. This year Northumbria in Bloom has nominated Durham City to represent them in the Royal Horticultural Society Britain in Bloom UK finals. Each entry into the Beautiful Durham Competition is a valued contribution to the overall efforts of the city.

Anti Social Behaviour Team Children playing ball games: Residents should try to speak to the parents before making an official complaint. Discussion, understanding and compromise can often be the best ways to resolve such issues. If ball games continue to be played recklessly, and there is a risk of property damage or excessive disturbance (for example due to foul language being used), this may be classed as anti-social

A family causing problems: Home visits are carried out; Tenancy Warnings issued; Risk Assessments carried out; Multi-agency meetings held; Acceptable Behaviour Contracts agreed. This approach can lead to no more reported incidents. Neighbourhood Wardens also monitor the area to give reassurances to local residents.

# 6A. Regeneration Fund:

Romaine Square: A litter bin has been installed and will be maintained by the Street Scene team.

Community Centre: J Blackburn, J Blakey, D Paget, M Ridley, and M Syer declared an interest but it was not prejudicial.

An application to the Regeneration Fund from Bowburn Community Association was presented to the meeting. The application applied for additional funds towards the cost of stage electrics (which was in the original refurbishment but had to be postponed because of lack of funds), and a chairlift on the steps at the side of the stage to make the stage accessible to all comers in the Community Centre(which was in the original refurbishment but had to be shelved because of lack of funds).

The total cost of the project was £4387 and the Community Association requested 100% of the funds.

It was agreed by members at this meeting to grant the total amount of £4387 to the Community Association. Julie Anson and Gillian Parvin, Regeneration Team DCC, agreed to the funding on behalf of Durham County Council. The project will be overseen by Gillian Parvin and Janet Blackburn. (G Parvin, J Blackburn)

M Ridley, chair of the Community Association, thanked the Partnership for the grant which ticks off more items on their wish list.

6Bi Highways: The speed humps were installed on Tail-upon-End Lane on Wednesday 16 April

6Bii Parkhill: The members of Parkhill Residents Association are still in discussion about future plans. A new community group 'Parkhill Neighbours' was recently set up representing those in Parkhill most affected by a proposed housing development by Hallam Land Management. New members are required to complete an application form to join and therefore provide a mandate for the organisers to speak on their behalf. As of 27 March 2014 there were 61 active members.

6Biii Community Centre: See 6A for chair lift and stage lights.

The AGM on 26 March re-elected the officers in post.

The Centre is doing well with new groups booking sessions once they know the potential of the Centre. 25 April Brenda Collins will give a performance (over 18s only) on behalf of the Banner Group and the Centre. Tickets are available from the Centre at £3.00 each. This is a joint event with the Banner Group (Item 9). Members of the Banner Group and Community Centre Association now hold an alcohol licence and will serve bottles and cans for the above performance and future performances.

6Biv Youth Centre: Grants have been awarded to enable outings in the holiday. The AGM is 12 May.

6Bv Environment: P Armstrong, Esh Developments, reported that the site is clear to obtain approval for their landscaping. Once this has been completed and the works undertaken Paul can concentrate on other matters i.e. the percent for art. Paul apologises that he cannot be more concrete than that at the moment. The secretary will continue to liaise with Mr Armstrong in June. (Janet)

6Bvi Planning: Grange Park Estate aka The Daisy Field:

The inspector did not see the flooding matters or the highway site lines at the junction as a problem or the loss of land for a Primary School, but did refuse planning permission on an unacceptable reduced distance by 0.9m between the site houses and the houses in Oakfield Crescent. He believed this would make the new development overbearing on at least some of the existing houses.

# 8. Reports and matters arising:

8ii Parish Council: The litter pickers collected 16 bags of litter and a TV set.

<u>8iii Quarry Liaison</u>: R Cowen attended a meeting held at Quarrington Hill Community Centre when representatives from the Quarry and the Council attended. The following points emerged:

- > Halls of Eppleton are currently appointed to bring waste to the quarry. However, the Permit from the Environment Agency is still in the name of Tarmac. A meeting had been arranged for w/c 7 April to discuss transferring the permit to Halls. Once this is finalised, it is likely Halls will start a much more regular operation at the Quarry but it will be under the aegis of LafargeTarmac.
- > The planning permission granted for Cold Knuckles Quarry needs certain matters to be undertaken before it can be implemented. This includes a further newt survey in relation to a proposal to re-grade the slope on the path leading up to Quarrington Hill cemetery, as the site is within 500 metres of a known newt pond. English Nature said the existing survey was out of date.

The quarry has promised to keep everyone informed of developments.

- > There was discussion in relation to the gradient of the path mentioned above and drainage issues on one of the permissive paths.
- > RC mentioned the article he had written for the December issue of the Interchange which included a reference to the grants that could be made by the Quarry.
- > Quarrington Hill churchyard: The notice warning people to enter the churchyard at their own risk was erected by the Parochial Church Council, but does not explain this. A new sign will be erected to state the ownership.
